 - Advised Susan/Ken that if more money is needed to please let us know and we can always do another vote and add more if we find it acceptable
 - **The larger panels that were to be ordered for a sensory wall in the sensory room were a lot more expensive on the Canadian website so we cancelled those. The MDT team feels the need will not be as high with 100 voices being removed from OLOP**
